The provisions of this Certificate of Compliance shall be interpreted and governed pursuant to the laws in Australia. This is to certify that GSM INTERNATIONAL (VETO SPORTS) warrants the product purchased is compliant to Australian Standard AS 4866.1-2007, when properly maintained and under normal use and service.

This means using only the fittings provided and attaching no other fittings or parts aftermarket. Also, having the product assembled and anchored in exact accordance with the manufacturers' user guidelines so as not to in any way damage the product during or after assembly.

This Certificate of Compliance is in lieu of any and all other certificates, expressed or implied. No implied compliance of merchantability is made and there are no certificates which extend to the use of the product for purposes beyond the product description.

This Certificate of Compliance does not apply to, and VETO SPORTS makes no warranties, express or implied, with respect to:

1. Fittings, parts, accessories or other goods manufactured by others.
2. Products that have been repaired or altered after delivery by anyone.

Only the goal post structure and base are covered under this Certificate of Compliance.

The manufacturer is not liable for any injury or death arising out of the misuse of the product if not assembled, anchored and/or weighted and used in accordance with the manufacturers' user guidelines; or if any product defects are not immediately brought to the attention of the manufacturer so repairs or replacements can be organised. If any defects are found with the product at any time, the user is to immediately cease use of the product and secure it to prevent use until the defects are rectified.

**AS 4866.1-2007**

Voluntary standard where it is considered best practice to adopt this standard as part of risk management.

**APPLIES TO**

All soccer goal posts; both socketed (sleeve base) and moveable (portable base).

**STRENGTH TEST**

Apply 180kg of vertical force to the centre of the crossbar for 70 seconds. Any collapse or other structural damage must be noted.

**IMPACT TEST**

Goals must pass 1 of these 3 tests.  
Impact force of < 200N when goal is released in both directions from its fall over point and have a static load of < 28kg at the centre of the crossbar when the goal is positioned as so there is a 300mm gap between the centre of the crossbar and playing surface.

Total weight < 28kg including all attachments.

Neither fall over or fail to return to its original position when a horizontal force of 200kg is applied to the centre of the crossbar with an unanchored goal.

**STABILITY TEST**

Neither fall over or fail to return to its original position when a horizontal force of 2000N is applied to the centre of the crossbar with an unanchored goal.

**MANDATORY STANDARD**

Mandatory standard came into effect on 30 December 2010. It is law for all manufacturers, suppliers and re-sellers to abide by this document.

**APPLIES TO**

Moveable soccer goal posts that weigh > 28kg.

**STRENGTH TEST**

**IMPACT TEST**

Have a static load of < 28kg at the centre of the crossbar when the goal is positioned as so there is a 300mm gap between the centre of the crossbar and playing surface.

**STABILITY TEST**

Neither fall over or fail to return to its original position when a horizontal force of 1100N is applied to the centre of the crossbar when the goal is installed using the recommended minimum ground anchor
